## ANNOUNCEMENT OF TRUSTEE VACANCY

The Board of Education, Morgan Hill Unified School District intends to make a provisional appointment to fill the vacancy created by the resignation of Amy Porter Jensen.

<b>Who can apply?</b>	Residents of the Morgan Hill Unified School District who are 18 years of age or older and registered to vote in the Morgan Hill Unified School District. An employee of a school district may not be sworn into office as an elected or appointed member of that school district's governing board unless and until he or she resigns as an employee. If the employee does not resign, the employment will automatically terminate upon being sworn into office, Education Code 35107(b)(1).

<b>Board action?</b>	It is anticipated that the Board will take action to appoint a candidate subsequent to the candidate interviews, at the special Board meeting on December 8, 2015 or December 11, 2015, (depending on the number of candidates.)

<b>Thursday, November 19, 2015</b>	Candidate Information Night 7:30pm – MHUSD District Office
<b>Friday, December 4, 2015</b>	<b>Candidate applications are due in the Superintendent's office by 5:00 pm.</b>
<b>Tuesday, December 8, 2015</b>	Special Board meeting to interview candidates in open session and select Board member. Appointment of Board member. Oath of Office will be administered (if additional day is not needed).
<b>Friday, December 11, 2015</b>	Depending on the number of candidates, interviews may be continued to Friday, December 11, 2015. Oath of Office will be administered (if additional day is needed).

<b>11.</b>	As a Board member, you have confidential information that leads you to believe that a certain administrative action you are supporting is correct and proper. For example, an administrator or teacher, popular with parents and teachers, may be reassigned or dismissed for compelling but confidential reasons. How would you handle public outcry opposing your stance?
<b>12.</b>	Your position on numerous issues is diametrically opposed to that of your fellow Board members. How would you handle this professional conflict?
